Comprehensive evaluation is followed by individual, family and group therapy. Medication management and routine drug and alcohol screens are available. My role as the developer and director of ASSET includes program development, administrative oversight, program marketing, oversight of training and supervision and performance of clinical duties.

The Center for Drug and Alcohol Programs (CDAP) outpatient clinic provides evidence-based psychiatric and psychotherapeutic treatment services. CDAP clinic offers individual and family therapy, day and evening Intensive Outpatient Programs, a Buprenorphine Maintenance Clinic, a Motivational Enhancement Therapy program, an Adolescent Substance Use Skills and Education Training (ASSET) program, and gender-specific groups. My role as a clinician and supervisor includes conducting and supervising assessments, individual, family, and group therapy. In addition, I developed a Women in Recovery group, designed for female patients of CDAP who are working to stay in recovery and who are looking to gain coping skills in the areas of emotional regulation, self-esteem, and relationship issues. I further specialize in conducting psychotherapy for individuals with co-occurring disorders, including Personality Disorders.

The Centralized Inpatient Programming Service (CIPS) is an interprofessional service that provides group-based educational and therapeutic programming for adult and adolescent inpatient individuals within the MUSC Institute of Psychiatry. Group leaders come from a variety of disciplines, including psychiatry, psychology, pharmacy, recreation therapy, occupational therapy, social work, and dietary. Group leaders also include community volunteers performing as peer counselors, pet therapists, spiritual leaders, and representatives from Alcoholics Anonymous (AA), Narcotics Anonymous (NA), and National Alliance on Mental Illness (NAMI). My role within CIPS has included taking the lead of assessing and analyzing treatment effectiveness, assistance in the development of the program structure and content, administrative oversight, consultation and supervision on complex cases, and leading educational and therapy groups to a variety of adult and adolescent inpatient individuals.
